**COVID-19 Waiver and Release of Liability by MHCEC Volunteer, Participant or Guest**

As you are aware, the COVID-19 pandemic has resulted in a national state of emergency. During the crisis, the Mount Horeb Community Education Center (MHCEC) is taking extra precautions to address the direct threat of COVID-19 to our participants, guests, and volunteers. Some special activities to protect everyone include:

- Performing extra cleanings of the facility, including workstations, restrooms, waiting areas, equipment and supplies;
- Requiring PPE, including face coverings (face masks) for volunteers, participants and guests in areas indoors;
- Requiring volunteers, participants and guests to regularly wash hands with soap and running water for at least 20 seconds;
- Requiring social distancing of 6 feet whenever possible; and
- Providing sanitizing wipes, spray and hand sanitizer throughout the facility.

Even with our precautions, due to the nature of our open working environment and the uncertainty of the spread and contagion of COVID-19, the MHCEC is requiring that each volunteer, participant, and guest agree to and sign this limited COVID-19 waiver and release.

**Agreement for Limited COVID-19 Release**

1. I am aware that there are risks associated with me and/or my child contracting COVID-19 by entering the MHCEC facility or receiving services from the MHCEC during the COVID-19 pandemic associated with entering the facility and/or being in contact with MHCEC volunteers and participants during the COVID-19 pandemic.
2. On behalf of myself and/or my child, I knowingly assume all possible COVID-19 exposure risks, both known and unknown, relating to my presence in the facility or receiving services from MHCEC.
3. I hereby forever release, waive, relinquish, and discharge the MHCEC, along with its owners, officers, directors, managers, employees, volunteers, agents, insurance carriers or other representatives, and their successors and assigns (collectively, the "MHCEC Representatives"), from any and all claims, demands, liabilities, rights, damages, expenses, and causes of action of whatever kind or nature, and other losses of any kind, whether known or unknown, foreseen or unforeseen, in any way related to the COVID-19 pandemic, (collectively, "Damages") as a result of me and/or my child being a participant, volunteer or guest of the MHCEC or receiving services from the MHCEC, all limited to claims based on the alleged exposure to the COVID19 virus because of any actions or inactions of any MHCEC Representative.

I further promise not to sue or bring any claims against the MHCEC, based upon any alleged exposure to COVID-19 during my participation or visit.
